64th ANNUAL MEETING & BOARD ELECTION NOTICE



The credit union's Annual Meeting will be conducted both virtually (online or by telephone) and in person on Tuesday, April 23, 2024 at 6:00 p.m.

NE PA Credit Union leadership will review the credit union's activities for 2023, and the credit union's Nominating Committee will present four nominees to fill four board vacancies. In 2024, Amy Berman, Constantine Christofides, Charles Green, and Lisa Kirschner are running for re-election. There can be no nomination from the floor. The credit union will not conduct a vote by ballot if the number of nominees equals the number of positions to be filled.

Members who opt to attend the meeting virtually will join the meeting by video conference from their personal device or by dialing into a conference line via phone.

Instructions on how to participate will be sent to all registered members via email prior to the meeting date.

Members who opt to attend the meeting in person should arrive at the credit union by 5:45pm (337 Clay Ave., Stroudsburg, PA 18360) on Tuesday, April 23, 2024.

Advance registration is required by April 19, 2024.

Help Protect Your Parents' Finances

It's heartbreaking to hear stories of people losing money (even their life savings) as a result of fraud or financial exploitation, especially if they are older and financially vulnerable. In fact, it's quite common. According to the Federal Trade Commission (FTC), people age 70 and older reported losses of \$567 million in 2022. You know your parents could be at risk, and you want to protect them, but how?



One place to begin is by looking for warning signs that your parents have been victimized, or are at risk of being influenced, manipulated, or coerced by a stranger or someone they know.

Watch for some of the following signs:

- Unusual bank account activity, including large or unexplained withdrawals, and nonsufficient fund notices
- Missing checks, credit cards, or financial statements
- Unpaid bills
- Lost money or valuables that can't be located after a thorough search
- Relationships with people who seem to have undue influence
- Unexplained changes to legal documents
- Declining memory and decision-making skills

Regularly checking in with your parents may help you spot issues that need to be addressed. If your parents have fallen victim to a financial scam or are being pressured for money from someone they know, they may be embarrassed or reluctant to tell you, even if you ask. Do your best to remain objective and nonjudgmental, and patiently listen to their views while expressing your own concern for their well-being.

Cold Weather Shelter Donation



The credit union is proud to support the Cold Weather Shelter located at the Stroudsburg Wesleyan Church in Stroudsburg, PA. In January, the credit union provided a \$500 donation and staff donated several bags of socks and bar soap. The shelter has room for 50 people, but they make room for more, if needed. Guests are provided a warm place to stay, food, a hot shower, and resources that can help with finding employment and housing.

There are many reasons for homelessness including mental illness, drug and alcohol abuse, and unemployment. Whatever the reason, the need is great, especially during the winter months. The shelter is open November 1st through March 31st from 7:00 pm to 6:00 am. If you'd like to help the shelter, consider volunteering or making a donation. Volunteers act as greeters to help guests check in, some volunteers stay overnight to help with the nighttime "lights out" and morning "wake up call" routines, and other volunteers drop off food.
